EKITISTATE SEXUAL ASSAULT REFERRAL CENTER

The Ekiti State Sexual Assault Referral Centre (SARC) is a one stop, free, survivor-centred initiative that prioritises the rights and needs of survivors of sexual violence. The SARC aims to foster a supportive environment where a survivor's rights are respected and where she is treated with dignity and respect. The Ekiti State Gender Based Violence Prohibition Law of 2019 provides for the establishment of a Sexual Assault Referral Center. Section 52 States, 'There shall be established for the State a Sexual Assault Response Center located at the Ekiti State Teaching Hospital Complex'.

The Ekiti State SARC has been established on the directives of HE Governor Kayode Fayemi, by the Ekiti State Gender Based Violence Law Management Committee, the body responsible for implementing the 2019 GBV Law in Ekiti State. The Ekiti State SARC, which shall be known as Moremi Clinic, will provide free, 24 hour access to medical, legal and counselling information.

Moremi Clinic (Ekiti State Sexual Assault Referral Centre) will provide the following free services:

- 1. Immediate medical attention to survivors of sexual violence. Medical assistance includes:
 - Screening and preventive treatment for HIV and sexually transmitted infections
 - Pregnancy prevention
 - Collection of forensic evidence
 - Screening for drugs where drink spiking is suspected
 - Providing a medico-legal report.
 - Medical examination of children where child sexual assault is suspected.

Professional workers will meet anyone attending the Centre, explain all the processes and ensure informed consent to the forensic examination. Examinations are conducted by a team of forensically trained female examiners. Service users can access other medical and support services if and when required.

- 2. Collection and management of relevant data: Primary data will be generated from SARCs for reporting rape and/or dealing with its immediate aftermath, in order to improve Criminal Justice System (CJS) responses.
- 3. Counselling and psycho-social support will be available for survivors and others who have been sexually assaulted at any time in their life.
- 4. Information, support and counselling for parents, family members and partners.
- 5. Education and information for community or professional groups.
- 6. Support for going through the legal process
- 7. Protective measures for children.
- 8. Collaboration with other government agencies for prevention, protection and care.

SEXUAL VIOLENCE AGAINST CHILDREN

The Ekiti SARC will also provide services for child victims of sexual abuse, for which there are special provisions to note. On June 5th 2020, HE DR Kayode Fayemi, Governor of Ekiti State, signed the Sexual Violence Against Children (Compulsory Treatment and Care) Law, 2020. Every child victim of sexual violence is entitled to

immediate and adequate treatment in any Hospital in Ekiti state. Under the provisions of this law,

- No hospital in Ekiti state must reject or refuse care or treatment of any child who is reported to have been sexually assaulted. Failure will result in the payment of a fine of N 500,000.00 or imprisonment for two (2) years or both upon conviction.
- Any Hospital who fails to report any case of child victim of sexual violence it receives to the nearest police station and any other government or non-government organizations relevant to child care or welfare will upon conviction be liable to a fine of N 1,000,000:00 and the default doctor upon conviction is liable to a fine of N 1,000,000.00.
- Any parent or guardian who fails to provide adequate information to any hospital on both the physical condition of the child & the circumstances surrounding the sexual violence, will be liable upon conviction to three (3) months imprisonment without an option of fine.
- Any parent or legal guardian whose conduct or utterances is aimed at preventing the hospital from reporting to the police commits an offence and is liable on conviction to three (3) months imprisonment without an option of fine.
- The law established a Sexual Assault Medical Response Scheme with the duty to facilitate a scheme for free and qualitative medical treatment for children who are victims of sexual violence at every local government of the State.
- The police shall not invite any child victim for investigation except such a child has been certified fit by the Chief Medical Director of the hospital.

- Any person or authority whose conduct or utterances causes substantial humiliation or emotional agony to the child victim, parent or legal guardian, will be liable upon conviction to imprisonment of not less than five (5) months without the option of fine.
- Upon conviction a person will be liable to a fine of N 500,000.00 or imprisonment for two (2) years or both, where a person stands by and fails to perform any duty under this law
- Medical reports of any treated child victim shall be sent to the police within 24hours of completion of treatment
- Where a corporate body commits an offence under this law, the head corporate shall be prosecuted.

WHAT TO DO IF YOU OR SOMEONE YOU KNOW HAS BEEN SEXUALLY ASSAULTED

- Do NOT bathe.
- Do NOT change your clothes.
- If the rapist used a condom and you have it, DO NOT destroy it.
- Do NOT go to the Police FIRST.
- Go to a HOSPITAL STRAIGHT.

Go STRAIGHT to Moremi Clinic at Ekiti State University Teaching Hospital (EKSUTH) Ado-Ekiti. If you do not live near Ado-Ekiti, if you call one of the helplines, you will be directed to a medical facility near you.

After you are done at the Moremi Clinic please go to a Police Station to make an official report. This is because the Police will still need to take you to Moremi Clinic (or to a hospital) if you haven't already gone there yourself. This way, your journey will not be made longer. Someone from the SARC will be with you throughout this process.

YOUR RIGHTS AS A USER OF THE EKITI SARC

Under the provisions of the Ekiti State Victims Charter (2019) if you are a user of the Ekiti SARC, you are entitled to fairness, compassion and respect. You have the following rights:

- Free services
- Prompt medical attention
- Professional conduct on the part of all responders
- Privacy
- Confidentiality
- Protection
- Assistance
- Explanation of procedures
- Information on your case
- Complaints in the case of a breach of any of the above rights
